PUBLIC HEARING FY24/25 BUDGET AMENDMENT: Motion to open the public hearing by A. Reuter, seconded by D. Meyer. Motion carried. Mayor Sieverding opened the public hearing to solicit comments for the FY24/25 Budget Amendment. There were no comments from citizens present and no objections on file with city hall. Motion to close the public hearing by M. Petersen, seconded by M. Gerardy. Motion carried.

RESOLUTION 2024-30 Approving the City's Proposed Amendment #1 to the fiscal year 2024-2025 Budget: Motion to approve by D. Meyer, seconded by M. Petersen. Motion carried.

RESOLUTION 2024-26 Approving Appointment to fill a Vacancy of Council Member for City of Preston: Mayor Sieverding reported that Leesa Budde has expressed interest in being considered to fill the vacancy and thanked her for her commitment. A motion was made to appoint Leesa Budde as Council Member by M. Petersen, seconded by A. Reuter. Motion carried.

OATH OF OFFICE: City Administrator, Sheryl Ganzer preformed the swearing in ceremony for Leesa Budde to perform the duties of office where she took the seat on council immediately following. The Council welcomes Leesa to the board!

STORM WATER DRAINAGE: Isabelle Johnson, Connie Gerber, Elaine Jensen and Chad Roling were present to discuss the issue of storm water drainage on Davis Street. Johnson explained that drainage has been an ongoing issue for the past three years and is getting bad causing ruts. Gerber added that during recent rains, the tube didn't hold back the water causing it to run into her field and driveway. Jensen added that the water backs up

across the street to her curb on the opposite side. Roling stated that in the winter it becomes icy and safety issue. It was also noted that the city owned sidewalk that the drain tube runs under needs replaced. Sieverding responded that the issue was looked into when the Amos Street project was being done. The contractors gave the city an estimate of what it would take to get the water to drain to the intake that is there, with the cost being \$30,000 - \$40.000. Petersen also responded that it was looked at in March and the culvert was completely closed with leaves and debris which was the problem of why it was backing up. The city crew are now scheduled to clean out the tube on the days that street sweeping is done and will look to replace the sidewalk above it. It was noted that there are other storm water issues, and the council must prioritize accordingly with the funds available.

WEST STREET LOT: Jesse Kilburg – Kilburg Construction and Joe Christiansen, owner of lot, addressed the council on the restriction of selling the lot only for purpose of building a residential dwelling. Kilburg said that with the growth of his business he would like to buy the lot as it would benefit his company as access for bigger trucks to his property where current utilities and sewer drain situations could be also addressed. Kilburg plans to expand his business, which would generate more utility revenue for the city also. After further discussion, council would like to see Christiansen market the lot for sale for residential until September, and then revisit the request at that time.

RESOLUTION 2024-28: Approval of the Re-assignment of Committees for 2025. With the council vacancy changes, Sieverding re-assigned committees. A motion to approve was made by D. Meyer, seconded by A. Reuter. Motion carried.

RESOLUTION 2024-29 – Authorization of 28E Agreement – Deep Creek Township. The Clinton County attorney's office prepared the contract and provided maps for each town with fire protection after redistricting was completed. A motion to approve was made by A. Reuter, seconded by D. Meyer, motion carried.

OTHER BUSINESS:

Sidewalk update: A proposed second letter to property owners for sidewalk replacement was presented and approval given to be sent.

Nuisance/Ordinance enforcement update: Marla Quinn's presentation has been rescheduled for next meeting, Tuesday May 27th.

Skid Loader purchase update: Petersen met with Kunau's to discuss specifications and request for proposals will be presented at the next meeting.

Town Hall entrance update: 2 proposals have been received for options for a new door and will be looking for suggestions to update entrance.

ADJOURNMENT: With no other business to be discussed, Sieverding asked for a motion to adjourn. A motion to adjourn was made by L. Budde, seconded by M. Gerardt. Motion carried. Meeting adjourned at 7:30 pm.
